

To help our Customers understand the surcharges we have put together a guide to the surcharging policies of the Carriers and where available Carriers materials and links.

DPD, Parcel Force & DPD Local

- Remote Collections £25.00 surcharge These are Third Party Collections booked with DPD, Parcel Force
- Wasted journey £10.00 surcharge (nothing to collect)
- Single Item over 100kgs £100.00 surcharge
- Single Item 1m or over £60.00 surcharge
- Bulk Surcharge Consignment weight is over 20kgs £2.00 per KG (If you have a
 consignment over 20kgs, we advise you to break it down into smaller consignments to avoid
 this charge).

DHL Domestic, DPD and DPD Local

All products have maximum specifications of 20.0kg, 1.0m on the longest side and 0.23 cubic metres before Out of Gauge charges apply.

DHL International

Charges for International Parcels are all based on the weight of the overall consignment. The weight used for charging will be the greater of either the total weight entered or the volumetric weight calculated using the dimensions of the product. Other surcharges that may apply:

- Overweight Pieces—A consignment with a weight of 70 kgs or greater will attract a £50 per shipment charge.
- Out of Gauge—An additional surcharge for items with a length of between 100 cm and 300 cm. £50 pershipment.

Fuel Surcharges

Carriers adjust the surcharge in line with the most suitable measure of diesel prices. The surcharge is linked to the consumer price in Sterling (GBP) of diesel fuel inclusive of duties and taxes, as measured by the European Commission Directorate General for Energy and Transport.

All Domestics services currently attract a 9% fuel surcharge (from the 2018) any changes to this charge will be advised on your invoice.

Europe by Road has a 15% fuel surcharge. Changes will be advised on your invoice.

International Air services fuel surcharge is currently charged at 20%. This figure changes month on month.

For any services that are based on weight where a later invoice is raised for discrepancy in the actual weight, the fuel surcharge is based on the overall actual weight of the consignment. For example if the weight is declared as 20kgs and the actual weight is 25kgs, you will be charged the additional 5kgs in a separate invoice together with the required fuel surcharge on the additional weight.
